- d. Submit a completed scholarship application;
- e. Will have completed 30 academic hours by the fall semester; and
- f. Have a 3.00 GPA.

Completed scholarship applications must be postmarked no later than Thursday, February 20, 2020 and mailed to Faye Gregory, GFWC KY Scholarship Chairman, PO Box 768, Manchester, KY 40962. You also have the choice of e-mailing your application to [faygregory@windstream.net](mailto:faygregory@windstream.net) (note there is no "e" after fay).

The scholarship recipients will be notified on or before March 12, 2020 and will be invited to attend the GFWC Kentucky Annual Convention in Lexington, March 26-29, 2020.

Once verification of enrollment is received by GFWC KY, the scholarship recipients will receive \$2,500 at the beginning of the fall 2020 semester.

  - b. Two letters of recommendation from non-family members
  - c. Essay of 200 words describing why you should be considered for the scholarship outlining your financial situation including financial aid you receive and if you are employed
  - d. List of volunteer and/or community activities with explanation of your participation
  - e. Statement of your goals and aspirations
